

## Procedure for wearing astrological gemstones

- 1. Please buy a gemstone as per your budget.
- 2. Normally I advise my clients not to buy expensive gemstone.
- 3. The range is approximately 5000 INR for the less expensive ones and INR 12500 for the more expensive ones (diamond and neelam). They are available in India in the above range but I do not involve myself in gemstone purchase nor do prescribe dealers etc.
- 4. Do not be too finicky about the purity and be ready to fit it into your budget even if you have to buy one with a lesser ratti. Do not over stretch your finances.
- 5. They need to be tested on you first.
- 6. Once you have bought the gemstone and as an example if you have been told to wear two gemstones (Pearl and Blue Sapphire); please test them one by one in the given example please buy the pearl first and keep it under your pillow for a week at night. If you do not get any nightmares and do not wake up in cold sweat in the middle of the night then please get in put in a silver ring and wear it as mentioned in your report. Then observe that nothing adverse happens for a month, if nothing adverse happens or things remain as is then keep on wearing it for the rest of your life.
- 6. If it does not suit you and something dramatically adverse happens then throw it off in a water body.
- 7. Continuing with the example above 6 weeks after buying the pearl, buy the blue sapphire and do the same exercise in steps 5 and 6 above, you have to be especially careful with the blue sapphire (and diamond) as it is an extreme stone and can have drastic side effects.
- 8. If it suits you then wear it for life otherwise throw it in a water body.
- 9. It is always wise to follow the instructions of your astrologer.

- 11. In general I do recommend that people take a phone consultation with me prior to wearing a gemstone.
